# IAA Experience — Performance of test drives



Dear Sir or Madam.

Test drives are always a special highlight at the IAA and fascinate many visitors. As part of the IAA Experience, you can offer test drives to interested customers, using Hannover's public roads (vehicles with conventional drives) and also the fairgrounds' (electric vehicles).

1. Conventionally driven Trucks, Buses and Light Commercial Vehicles: We offer the parking location (see enclosure 1) and corresponding tickets for vehicle entry and exit. Exhibitor passes for your staff must be taken off your exhibitor pass budget or can be ordered directly via the "Exhibitor Shop".

The charge for one parking location of approx.  $3.5 \times 15$ m for trucks/buses is 599.00 € plus VAT, for one parking location for light trucks of approx.  $3.5 \times 10$ m is 249.00 € plus VAT.

#### 2. Electric-powered Commercial Vehicles:

Along the 2nd Avenue we offer the opportunity to perform e-test drives (see enclosure 1). The approx. 1.8 km long route will be marked and separated by barriers and information-signs (if necessary). Nonetheless, it is important that drivers keep a reasonable speed since the route won't be exclusively available. In order to ensure a greater visibility for the e-test drives and attract more visitors, the registration area will be located on the tree-lined avenue between Halls 11 and 14/15.

To highlight your starting position, you have the option to also book a pagoda incl. a flagpole. An electrical connection can be ordered via the "Exhibitor Shop". Any charging stations, if necessary, shall be organized and provided by yourself.

The following services will be performed by the VDA:

- → Parking location in the starting area (ca. 3.5 × 8m, for buses p.r.n. longer)
- → Barriers & routing (incl. marshals)
- → Shuttle tickets for driving on the test track

The charge for one parking location for electric vehicles is 1,149.00 € plus VAT for vans (LCV) and 1,418.00 € plus VAT for buses (or other HCV). In addition, you have the option to book a pagoda (incl. carpeted floor and flagpole) for 970.00 € plus VAT.

The costs for power supply can be found in the "Exhibitor Shop".

The VDA assumes no liability for material or personal damage resulting from the test drives. The VDA only provides the space for the test drives which are conducted in the sole responsibility of the participating companies. In addition, the <a href="#">IAA Exhibition Conditions</a> apply.

As in previous years, we do not offer a central registration area for interested guests. The contact with customers and the on-site handling (incl. insurance, check of the driver's license etc.) take place at your booth and lie, as well as the complete performance of the test drives, in your responsibility. Exhibitors are free to decide whether their visitors may drive the test vehicles themselves or participate as passengers during the test drives. The participating guest must sign a waiver with the exhibitor (to have ready by the exhibitor; please provide us with a copy of the document before the IAA) and prove that they hold a valid driver's license for the specific vehicle (in case they drive the vehicle themselves). It is the exhibitor's responsibility to check that the guests are capable and in the state to drive the vehicle themselves. A person familiar with the specific vehicle must accompany the test driver in the driver's cab at all times. Each participating vehicle must be licensed for road use and covered by liability insurance.




